1. PARISH COUNCIL AS FREEHOLDER OWNER

1.1 EAST VIEW KICKABOUT AREA

OWNERSHIP

Freehold gifted to Sedlescombe Parish Council in 1995 for use as a play area. ESX 11650, RR/94/2252 refers

VALUATION

Value as community land - £1.

BYELAWS AND DOG ORDERS

- There are no byelaws.
- There is a "The Fouling of Land by Dogs (Rother District Council) Order 2007" affecting this land. Dog faeces must be collected or the person in charge of the dog is guilty of an offence.

FURNITURE

- 2 X Record football/basketball steel units in tarmac area.
 - Concrete litter bin – residents asked not to be dog faeces or soiled nappies in this bin

1.2 RED BARN FIELD NATURE PARK

OWNERSHIP

Freehold Owner – Sedlescombe Parish Council, purchased December 1998/January 1999, ESX 255274 (following loss by Solicitor of ESX27884). The Parish Council has retained ownership (leased to the Sedlescombe Village Hall charity) of the village hall car park.

Legal agreements: a) Right of way and access to well; b) Covenants imposed on sale of land for village hall (ESX255944); c) Lease of village hall car park to village hall.

VALUATION

Purchase value £13,500 (after removal of part of the holding for construction of the village hall).

DOG ORDERS

The Exclusion of Dogs (Rother District Council) Order 2008 has been introduced by Rother District Council making it an offence for a person in charge of a dog to permit the dog to enter or to remain on the land.

FURNITURE. The following items of furniture are on the land:

 2. Recycled plastic disabled picnic table

 4. 1 interpretation board with new glass reinforced plastic panel (2007). (1 other removed 2006)

1.3 SEDLESCOMBE SPORTSFIELD CAR PARK

Freehold Owner – Sedlescombe Parish Council (ESX 109895), purchased 1984.

Car park extended 2004. Signs at car park replaced November 2004. Environment Agency signs at car park.

1.4 VILLAGE GREEN

Grass area in centre of Village Green with Grade II Listed Pumphouse building over lead pump (commemorative inscription) surrounded by railings, 2 oak commemorative benches (Mjr Haddon). There are three trees on the Green.

OWNERSHIP

Parish Council registered owner since 1973.

VALUATION

Insurance valuation of Pumphouse increased annually. Green valued as community land - £1.

BYELAWS AND DOG ORDERS

- Various byelaws
- The Fouling of Land by Dogs (Rother District Council) Order 2007 applies to the Village Green making it an offence for anyone not to clear up faeces after their dog.

FURNITURE

- 3 commemorative seats (Sir John Keeling) around top oak with plaque on ground re the tree.

1.5 BUS SHELTER

OWNERSHIP

Freehold owner of the land on which the bus shelter stands. The land was gifted to the Parish Council by Paul Thomas on 16 April 2008 ESX314412.

BUS SHELTER

As part of planning permission to develop land at the Park View, The Street, Sedlescombe, the developer is required to provide a new bus shelter. [RR/2004/3642/P and RR/2007/2199/P]

2. PARISH COUNCIL AS LESSOR

2.1 SEDLESCOMBE SPORTSFIELD

OWNERSHIP

Parish Council purchased the freehold of the field and pavilion (there was no car park) from Pestalozzi Children's Village in 1984 for £15,000. There is an obligation under a covenant imposed on the land's purchase on the Parish Council to contribute towards maintenance of the Pestalozzi road "according to user".

LEASE

Field including all buildings leased to Sedlescombe Sports Association:

- Under 30-year lease 1985 to 2015. Surrendered by Sports Association in 2004.
- Under 30-year lease from 01/02/2005. £1/p.a. peppercorn rent. NB Sportsfield Car Park is excluded from the Lease. (See 1.3 above)

Sports Association responsible for maintenance of all land and buildings apart from the car park.

VALUATION

At last valuation, valued at £30,000 amenity land.

BYELAWS AND DOG ORDERS

- Parish Council Dogs on Leads Byelaw (one of only two remaining in Rother District).
- The Fouling of Land by Dogs (Rother District Council) Order 2007 applies to this land.

FURNITURE & SIGNS

There are three seats, a litter bin (new 2003), a dog bin, a kissing gate into field (new November 2003). Signs replaced at bridge April 2004. Environment Agency signs at bridge and end of sportsfield. There is a metal sign on the tree at rear of the pavilion.

2.2 SEDLESCOMBE VILLAGE HALL CAR PARK

OWNERSHIP. Sedlescombe Parish Council is the Custodian Trustee of the Village Hall. Cllr Pauline Glew is a Trustee of the Village Hall appointed by the Parish Council.

LEASE

Sedlescombe Parish Council has retained the Car park land and on 17/11/2000 granted [a 25 year lease](#) to Trustees of the Sedlescombe Village Hall Charity - Colin Ivor Pritchard and Sylvia Lydia Cook. Rent £1/p.a. in advance on 1 January each year.

VALUATION

Valued as community land - £1

3. PARISH COUNCIL AS PARTNER TO AN AGREEMENT

3.1 BREDE LANE CAR PARK

OWNERSHIP. Rother District Council

AGREEMENT

Rother/SPC maintenance agreement 2006-2011.

DOG ORDER

The Fouling of Land by Dogs (Rother District Council) Order 2007 applies to this land making it an offence for anyone not to clear up faeces after their dog.

FURNITURE

- Tourist information board owned by Sedlescombe Parish Council on wall of public conveniences (Rother/SPC agreement from 28/05/02)
- Dog bin owned by Sedlescombe Parish Council (Rother/SPC agreement from March 1998)

4. PARISH COUNCIL AS CHARITY TRUSTEE – PUBLIC PLAYING FIELD AND RECREATION GROUND

OWNERSHIP

Sedlescombe Public Playing Field and Recreation Ground Trust (Charity Commission No.305305).
Sedlescombe Parish Council is the sole trustee. The land and everything on it belongs to the Charity.

VALUATION

Value as community land - £1.

DOG ORDER

- There is an Exclusion of Dogs (Rother District Council) Order 2008.
- The Fouling of Land by Dogs (Rother District Council) Order 2007 applies to the whole area making it an offence not to clear up any faeces after your dog.

2009 - Area to be used by the Netball Club (and Junior Netball Club) on two evenings a week for six months, April to September inclusive, payment of £60/calendar month, payable in arrears will be made to the Public Playing Field and Recreation Ground Trust.
